DEPARTMENT RULES:

1. This show is an ARBA Sanctioned show and will be governed by the rules set forth by the American Rabbit Breeders Association as they apply to Fair Shows and Agricultural Expositions. Submission of an entry form represents your acceptance of these rules.

MEMBERSHIP DUES:

ADULT: \$20.00 PER YEAR, 3 YRS \$50

YOUTH: \$12.00 PER YEAR, 3 YRS \$30

COMBINATION HUSBAND/WIFE: \$30.00 PER YEAR, 3 YRS \$75.00

SINGLE ADULT FAMILY: \$20.00 PLUS \$5.00 PER YOUTH PER YEAR, 3 YRS \$50.00 PLUS \$10.00 PER YOUTH

HUSBAND/WIFE FAMILY: \$30.00 PLUS \$5.00 PER YOUTH PER YEAR, 3 YRS \$75.00 PLUS \$10.00 PER YOUTH

2. This is a **carry case show**. All animals will be subject to a visual health inspection by fair board personnel at the fairgrounds. Any animal showing signs of disease will be excused for the day, and all entry fees forfeited.

Animals to leave fair grounds in a timely manner after conclusion of the show.

3. The Fair Board of Directors shall reserve the right to reject or refuse, and to order the removal of any exhibit which, in their opinion, is not eligible or worthy of showing or has not met the livestock health requirements.

4. **Entries fee is \$4.00 per animal, mail, online fair or email. Fur/Wool Entry Fee \$2.00 per animal.**

5. **Day of Show Fee is \$5.00. All Day of Show entries must check-in no later than 8:00AM Sharp!**

6. **Access to the Show Ring/Tent on the Fairgrounds will begin at 7:30AM.**

7. ***Entries are accepted by: Email & ONLINE August 1, 2024, Mail entries must be postmarked by July 31, 2024. All entries must be paid even if exhibitor cancels for the show. If you cancel the day of the show you must still pay your entry fee. Failure to pay will result in your not exhibiting in any part of the fair in the future.***

8. Due to time constraints, entry for **ONLY 250 animals will be accepted**. Please mail your entry accompanied by your check to Ulster County Agricultural Society, PO Box 71, New Paltz, NY 12561.

ENTRIES ON THE DAY OF THE SHOW. NO REFUNDS ON SCRATCHED ENTRIES. ENTRY FEE MUST ACCOMPANY ENTRY

FORM. Any entry accompanied by a check that is returned NSF will be charged a \$25.00 handling fee and no points, paybacks or specials will be awarded until all fees are paid. Fees must be paid within 10 days of notice.

9. All rabbits are to be permanently tattooed in the left ear and it must be legible as per ARBA rules.

Judging will be done by private ear number.

10. Three call rule will be used.

11. Substitutions will be permitted in the same breed, variety and class only.

12. Rabbits are to be in the show ring by 8:00 AM judging will start promptly at 9:00 AM. Passes will be available for exhibitors only. All others are expected to pay the gate fee.

13. There will be No Breeding Allowed in the Show Tent.

14. **NO PETS PLEASE.** (Dogs, Cats, etc.)

15. **AWARDS:** Ribbons will be awarded through third place. Rosettes will be awarded for Best of Breed and Best Opposite Sex of Breed, Best Fur/Wool. Breeds must have 10 rabbits in the breed, with the exceptions of rare breeds, per ARBA rules. Trophies for Best in Show and Reserve Best in Show will also be awarded.
